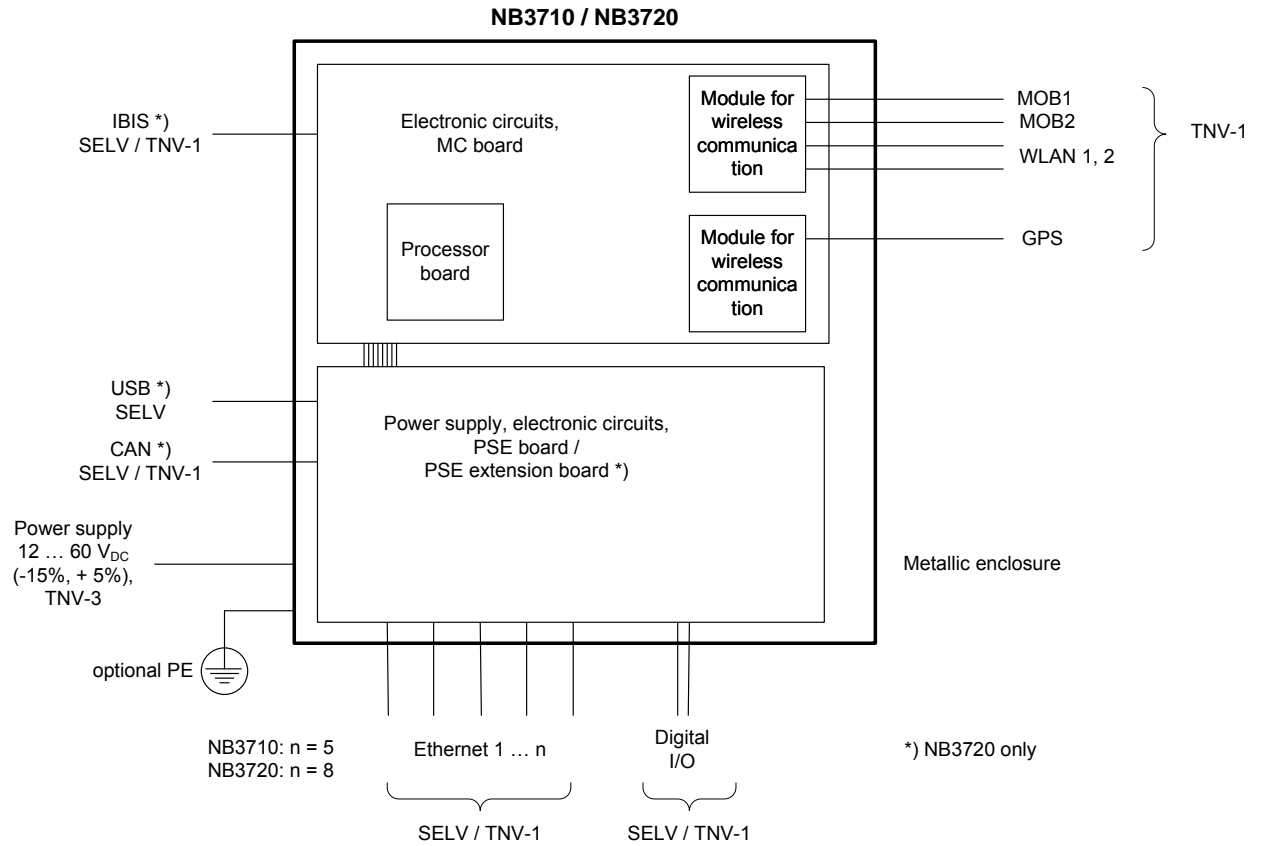

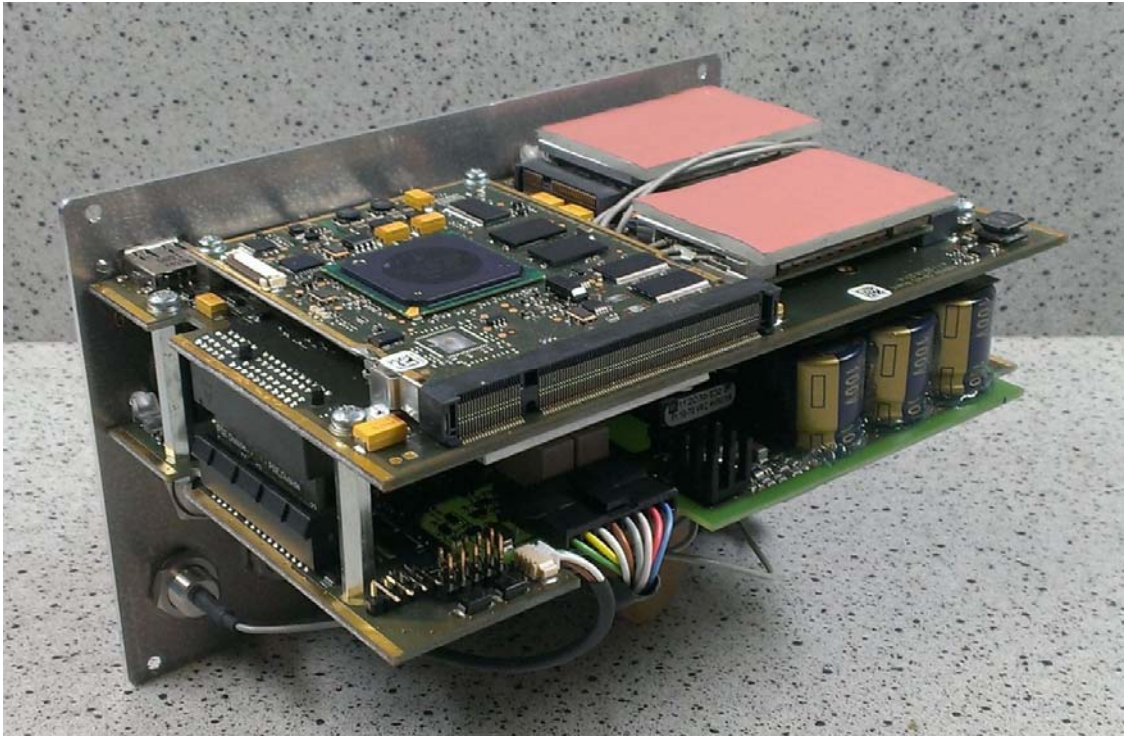

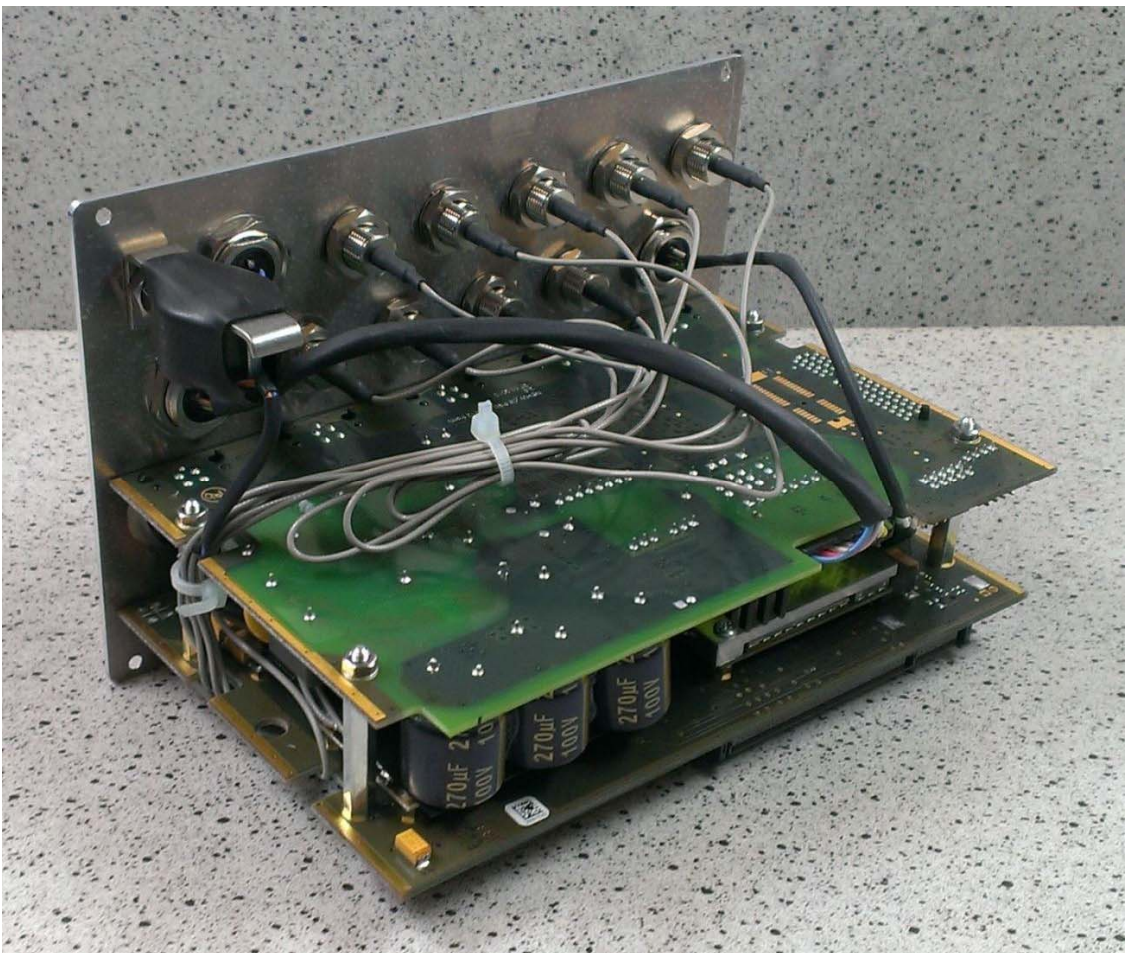


**NB3710, detail view of connectors**



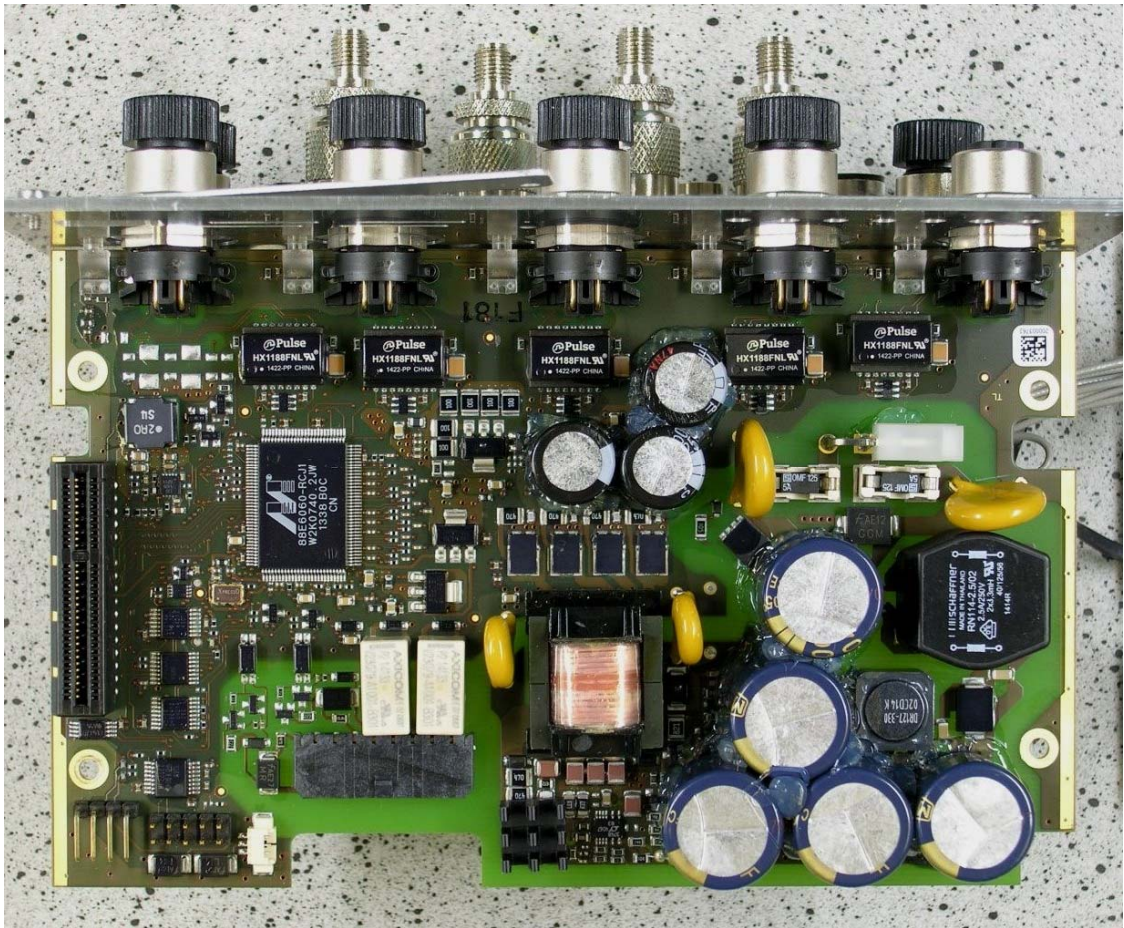


Cover of NB3710 removed, top view

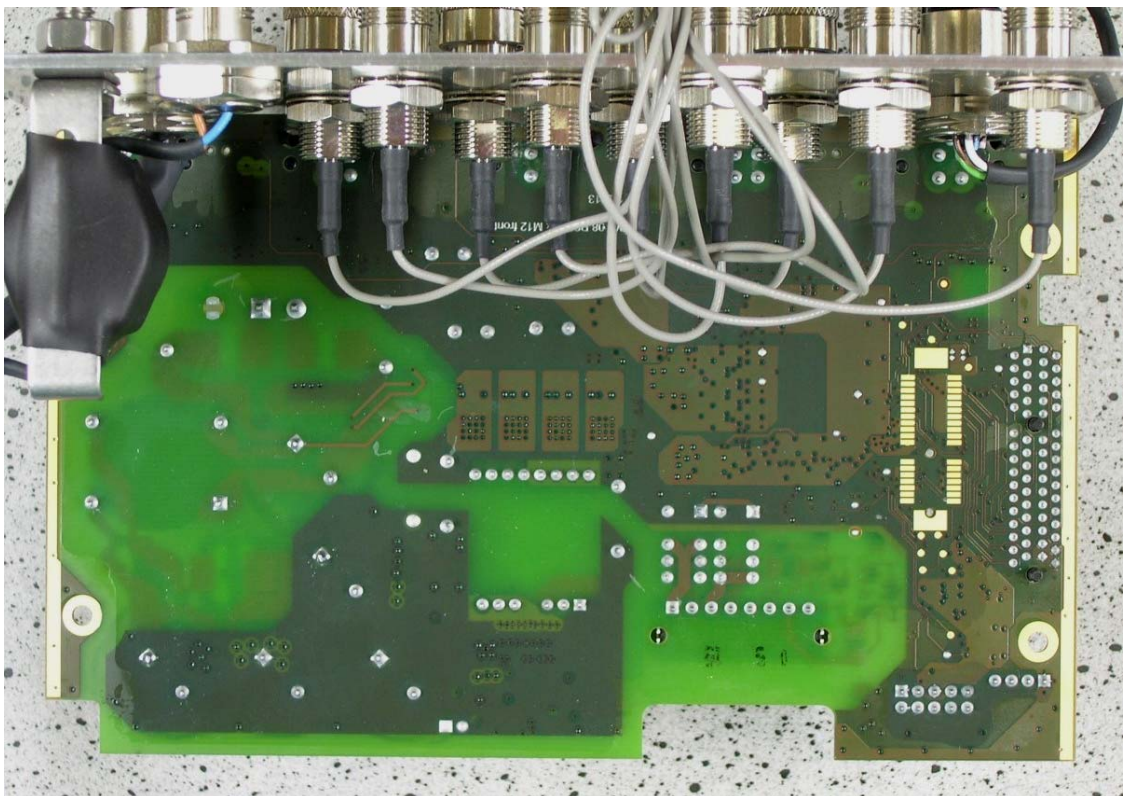


Cover of NB3710 removed, bottom view



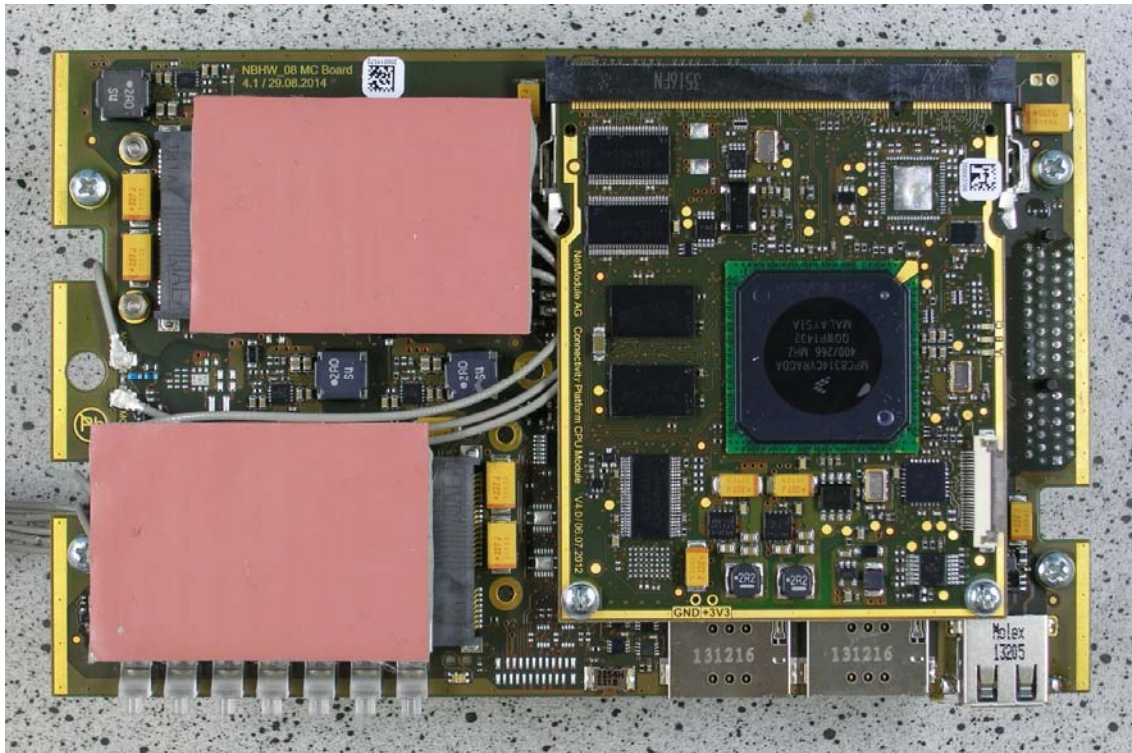


PSE (5x M12 front), components side

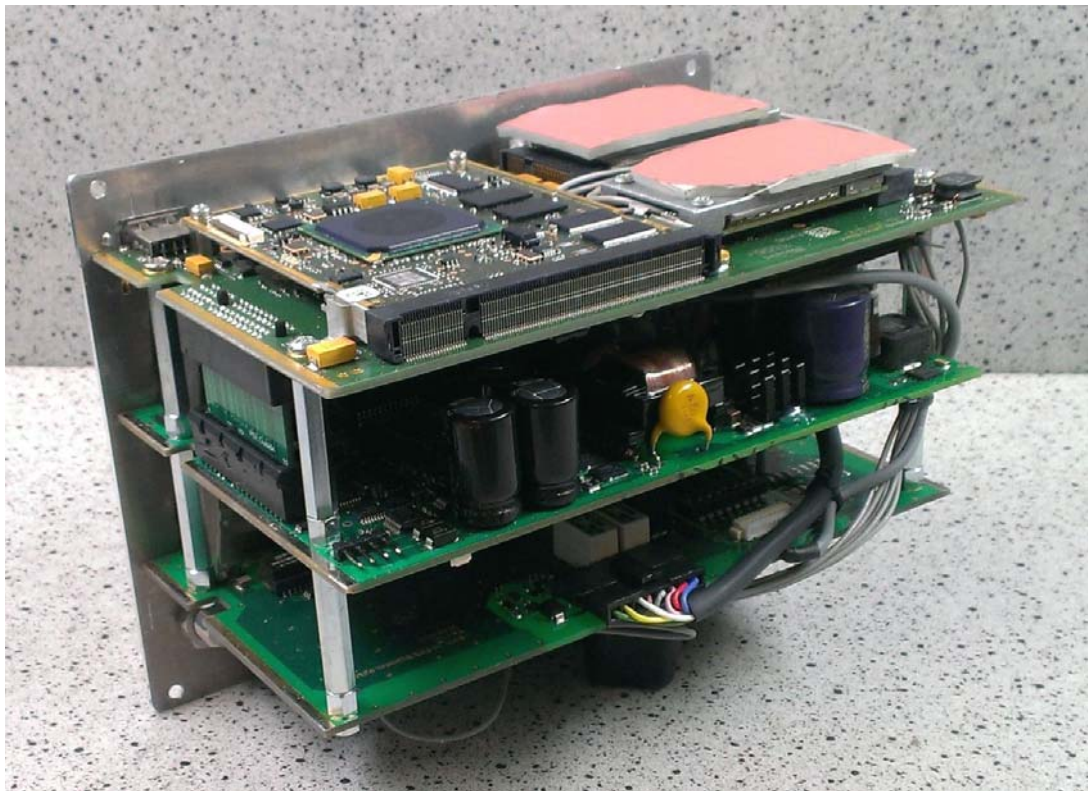

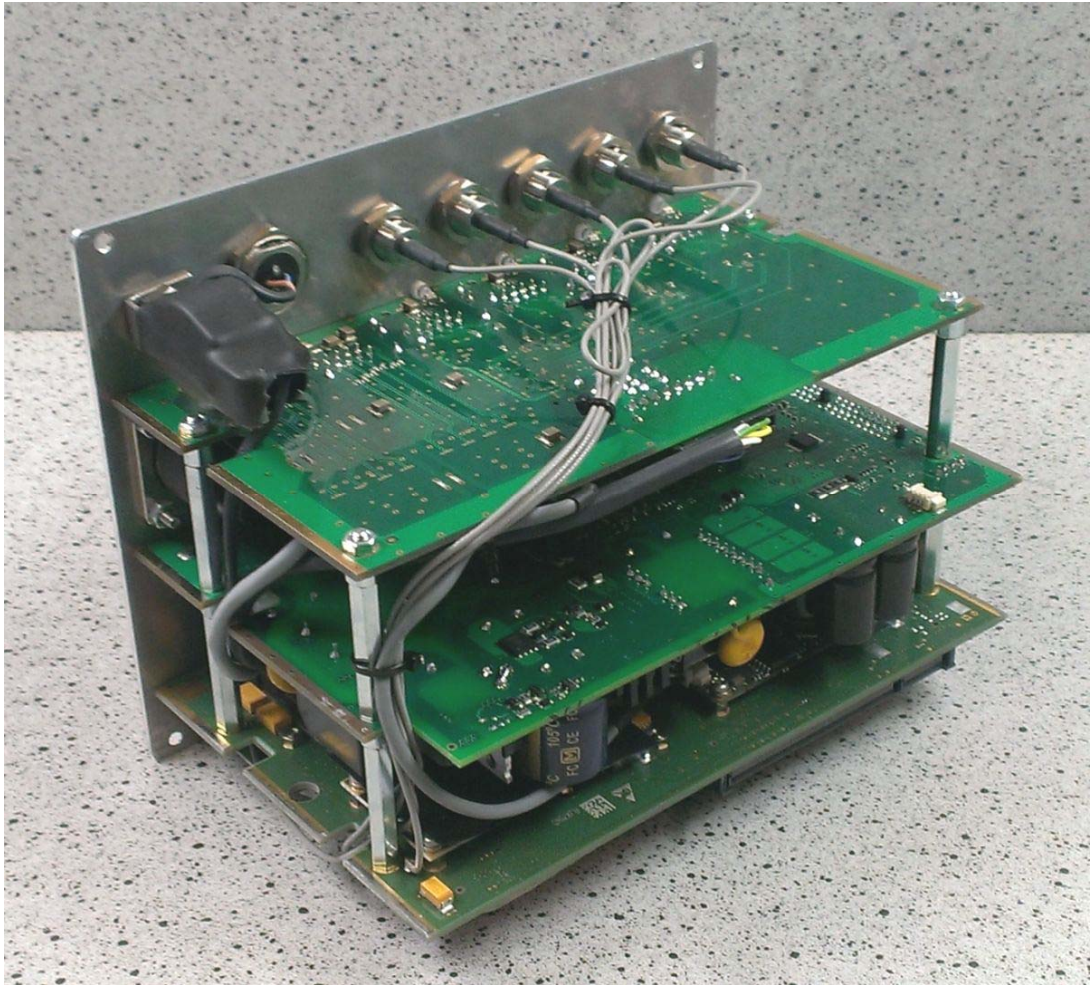


**NB3720, detail view of connectors**

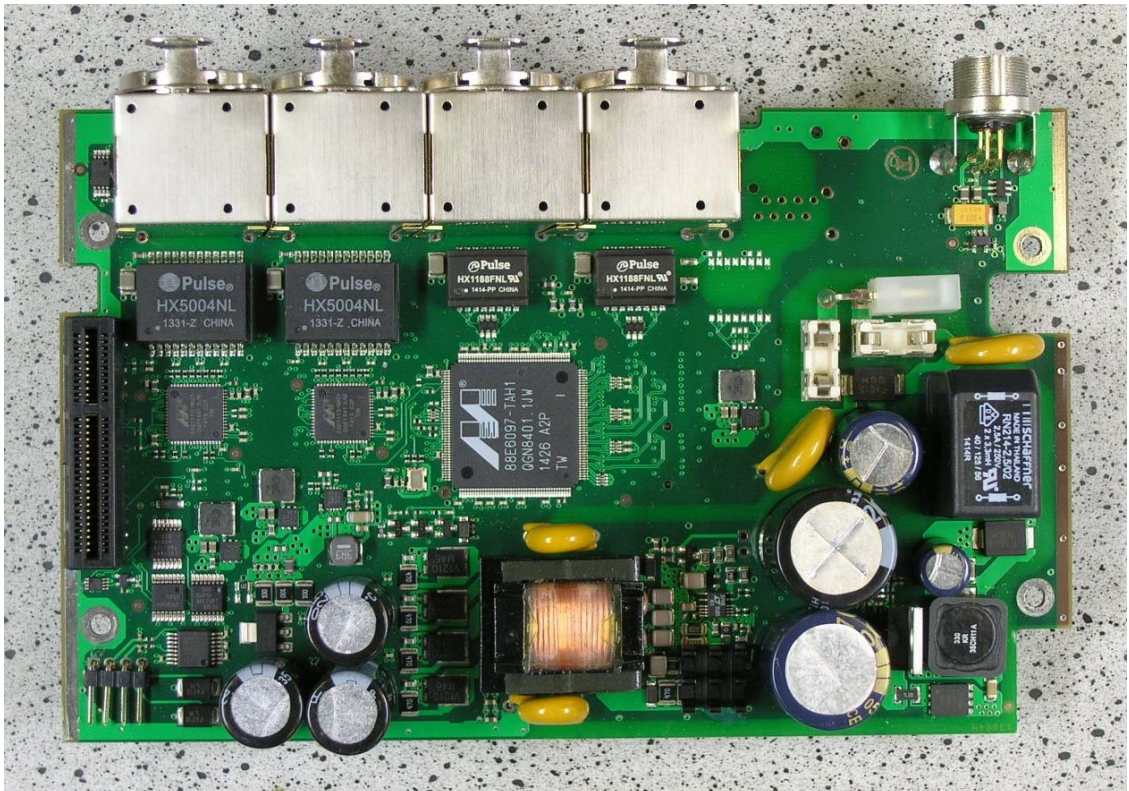


**Cover of NB3720 removed, top view**



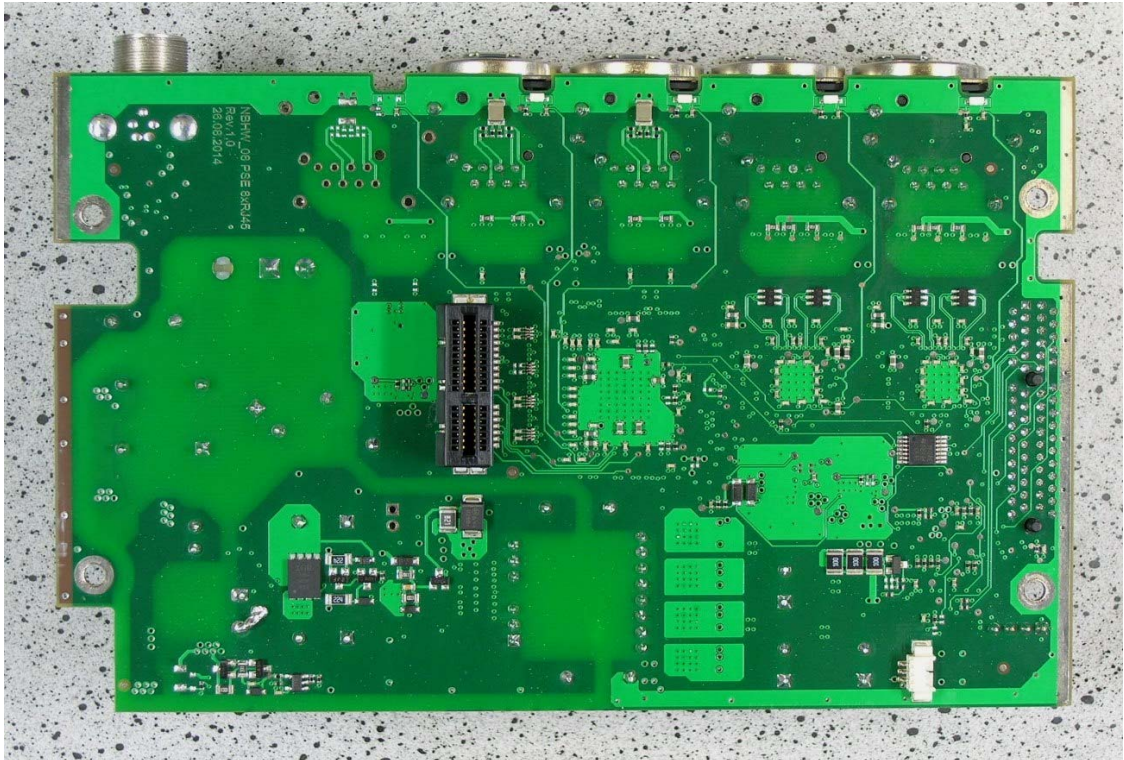


Cover of NB3720 removed, bottom view

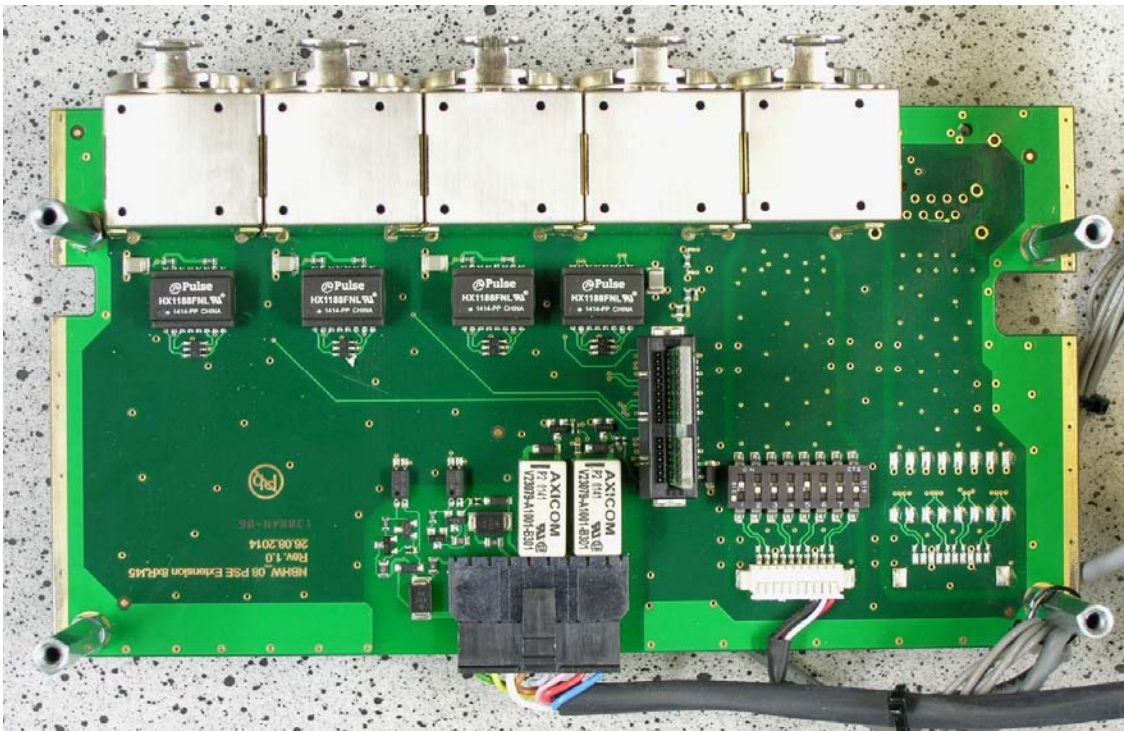


PSE 8x RJ45, components side

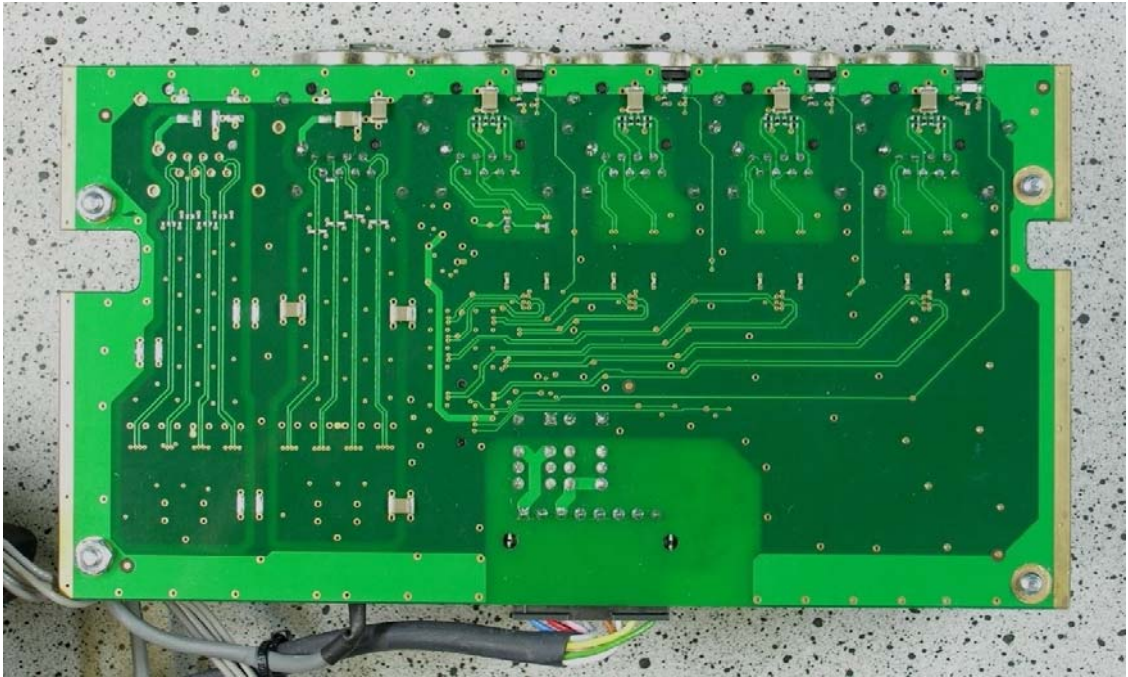




**PSE 8x RJ45, soldering side**
